MAJOR RESPONSIBILITIES

- Under direction of the Assistant Commissioner of Communications and Strategic Initiatives, develop and oversee Agencywide Operations and Maintenance (O&M) program designed to help the City achieve its energy and greenhouse gas emissions reduction goal of 30 percent by 2017.
- Work closely with the Department of Citywide Administrative Services (DCAS), Agency Energy Liaison Officer (ELO), and individual facilities to compile and analyze data for program development and performance measurements.
- Meet and communicate regularly with ELO to review reports, track energy budget information, and monitor projects.
- Chair energy subcommittee of the DPR Sustainability Taskforce to implement O&M program.
- Oversee energy awareness and building operators training for DPR staff in coordination with Parks Academy and DCAS.
- Conduct site visits to identify and implement building operations best practices at DPR facilities to reduce energy use.
- Coordinate with DCAS Department of Energy Management (DEM) and agency senior staff to develop agency measurement metrics and reports to ensure compliance with citywide goals, auditing requirements and operational protocols and standards.
- Partner with DCAS DEM and other agency managers to develop, monitor and deploy agency's Computerized Maintenance Management System (CMMS) so the preventative maintenance best practices are implemented and followed.
- Collaborate with Citywide and agency-based Engineering staff to integrate energy efficient HVAC equipment and lighting systems into new construction and reconstruction projects.
- Assist Borough Supervisors of Mechanics, Stationary Engineers and maintenance staff in evaluating HVAC and energy equipment to ensure effectiveness and operational efficiency. Assist facilities in identifying O&M staffing needs.
- Review and recommend equipment purchases to ensure energy efficiency when replacing obsolete or inoperable equipment.

OUALIFICATION REQUIREMENTS

- Eight years of full-time experience in construction, repair, alteration and/or rehabilitation of multiple dwellings, commercial, industrial or public buildings in the capacity of general contractor, superintendent of construction, procurement specialist, evaluator responsible for cost estimation, or as a field supervisor or as an inspector, at least 18 months of which must have been in a supervisory or administrative capacity involving responsibility for a large number of buildings or
